

How to deposit a newly accepted conference paper.



This guide explains how to use the University publications system (Symplectic) to create a manual record for a newly accepted conference paper, link it to any associated funding and deposit the full text.

A. Log in to the University publications system

1. Go to <https://publications.leeds.ac.uk> and log in with your IT username and password
2. Under My Actions, click on 'Accepted for publication? Deposit your work'
3. Click on the 'Conference paper' button below the guidance text
4. Check if your output already exists by using the duplicate check, or click Skip to continue

B. Create a manual record

At the point of acceptance it is likely you will only have basic information about the paper. It is not necessary to fill in all fields – those that are mandatory are marked with an asterisk * and advice on completing them is given below. Refer to the appendix for advice on filling in the optional fields.

What is your relationship with this conference paper?


- Select your (or the person you are impersonating's) relationship with the conference paper. Selecting either author or editor will populate the corresponding field further down the form.

Title

- Using appropriate capitalisation, enter the title of the conference paper.

Authors


- If you have already stated you are the author then your name will already appear here. To add additional authors, enter their names one at a time - last name and initial(s) with no spaces or full stops. Enter them in the order they appear on the paper.

If Symplectic finds a match in the system you will need to confirm or reject it. If you confirm an author, the publication will be added to their pending list and they will not need to create a separate record for that paper, reducing the chances of duplicates being added.

Status

- Choose from the drop down menu. If depositing on acceptance, choose 'Accepted'

Date of acceptance

- Having set the status to 'Accepted, you are required to supply the date your paper was accepted for publication, following any revisions resulting from peer review. Click on the calendar icon and choose the acceptance date.

Name of conference

- Enter the full name of the conference e.g. International Workshop on Research Findings on Sustainable Heating Provisions and Cities: Theory, Practice and Future Implications

Conference start date

- Click on the calendar icon and choose the date the conference started.

Click on Save

C. Link to funding

- If the research was externally funded and the grant(s) can be seen in the list, click on the appropriate 'Link' button(s) and click on 'Done'
- If the research was externally funded but the grant(s) cannot be seen in the list, click on 'Grant not listed'. You could also click 'Grant not listed' if you do not have the funding information to hand and return to add it retrospectively by going into the publication record
- If the research was not externally funded, click on 'Not externally funded'

D. Deposit the full text

1. Read the institutional advice tab information to confirm the file version you should deposit. In most cases this will be the author accepted manuscript
2. Click on Browse... next to Choose file and navigate to your file
3. Confirm the file version (e.g. Author accepted version) from the drop down menu and click Upload
4. On the next screen, select the embargo period if applicable/known. The Library checks and applies embargoes required by publishers on your behalf
5. You can add a comment (note) if you want to. This will not be publicly visible. Also let us know if you think any of HEFCE's open access policy exceptions apply to your output – see link to exceptions information on the advice tab
6. Click on Deposit my publication – a confirmation screen tells you the process has been successful and suggests any other actions you might want to undertake e.g. claim publications
7. Library staff will shortly carry out checks on your item. We will only contact you if there are any problems with your deposit.

Appendix - Filling in the optional fields

Abstract

- Copy and paste the abstract from your manuscript. Some items may not have an abstract, in which case leave the field blank. Note that formatting such as italics, bold text, underlining and line breaks do not show in Symplectic.

Keywords

- Add keywords from the manuscript to the record if there are any (often found after the abstract). Each keyword should be entered separately and the + Add button clicked after each one has been typed in. The first letter of the first keyword phrase (i.e. Magnesium compounds) should be capitalised. Capitalisation then only applies to names and titles for subsequent keywords e.g.
 - Magnesium compounds
 - North Africa
 - Iron

Editor(s)

- Where applicable. Follow the same process as for Authors.

Publication date

- Where applicable. Click on the calendar icon and choose the appropriate date.

Online Publication date

- Where applicable. Click on the calendar icon and choose the appropriate date.

DOI

- Where applicable. Enter the DOI e.g. 10.1000/xyz123.

Conference finish date

- Click on the calendar icon and choose the appropriate date.

Conference place

- Enter the City and Country, e.g. Edinburgh, UK

Published proceedings

- Once you start to type you will be able to select the title from a drop down menu. If the publication isn't listed, enter the full title of the journal, with no abbreviations. If entering manually use capitalisation for all major words e.g. American Journal of Diseases of Children.

ISSN/eISSN

- In some cases these will be autocompleted when you have selected the journal title from the drop down list. If not, please enter manually e.g. 0045-7825.

ISBN-10/ISBN-13

- Enter either the 10 or 13 digit ISBN number for the published proceedings if there is one. e.g. 9780099590330

Volume/Issue/Pagination

- Where applicable. The page count should be left blank.

Publisher

- In some cases this field will be autocompleted when you select the journal title from the drop down list. If not, and you know the Publisher, enter it in full e.g. Wiley-Blackwell or Social Policy and Society.

Publisher URL

- If there is a DOI add the prefix <http://dx.doi.org/> and then paste in the DOI. It should look like this <http://dx.doi.org/10.1016/j.buildenv.2013.03.006>

Language

- This field can be left blank.
